Discussion covered the following topics: Gateway amendment is minor just moving to within boundary. concerns cremated remains plots moved away from the hard standing area. Area split into two areas with a hedge as part art of biodiversity net gain (BNG) requirement. If hedge moved back to original position, so plot no longer separated BNG would have to be for whole site and there is a risk of planning refusal unless requirement reviewed, and new proposal put forward. Other preferences for hedge species, but these can be dealt with as a variation. Council wants to move forward with application in a timely manner. Application to be sent to trustees prior to submission as per agreement. Suitability of 5 bar gate from an aesthetic consideration.
