3 TO CONSIDER AND FORMULATE A BUDGET FOR BRANDON TOWN COUNCIL FOR THE YEAR 2023/24

The Chair introduced the subject and put to Council that the format of the meeting would follow that previously used at the January 2022 meeting. Cllr Lukaniuk confirmed that Suffolk County Council had increased their budget by 3.3% and West Suffolk by 5%. Brandon Town Council proceeded to review a draft budget amounting to £393,066.06.
