Planning Application – 10-12 High Street, Brandon

Change of use from former bank (class E) to hot food takeaway (Sui Generis.)

Cllr Moore expressed his amazement at the appearance of a further fast-food outlet in Brandon High Street. Cllr Brabbs stated that Brandon High Street appeared to be coming a fast-food mecca for the area. Cllr Wittam stated that the area needed the payment of business rates to the local economy. Cllr Brabbs queried if the exit onto the High Street was being utilised. It was noted that this exit would not be used. Cllr Moore noted that drivers were not observing the left turn only signage at the junction of Thetford Road and were using the car park opposite to avoid having to traverse the George Street one way system. Cllr Lukaniuk stated that the marketplace will decide the continued viability of the premises but did comment on the frontage of the building not conforming with the conservation area in which the building is sited. A general discussion about the possible parking at the front of the building close to the traffic lights took place, as it was noted that this previously caused a problem when there was a cash machine installed at the bank. A vote then ensued.
