Re-consultation – Old Library Site, Bury Road, Brandon 8 dwellings and 12 apartments. Associated parking and landscaping as amended by plans received on 2nd November 2023.

Cllr Brocklehurst commented that the biggest consideration is that the exit/entrance road is on a bend. Cllr Lukaniuk commented that initially they wanted to build thirty-three houses but after working with West Suffolk Council this is now down to twenty and includes some affordable housing. Additionally, Cllr Lukaniuk noted there had not been any complaints. Cllr Kostecki was also conernced about the exit/entrance as Bury Road can get very congested. There was a general discussion. Cllr Brocklehurst wondered if it would enable the speed to be reduced to 20mph in Bury Road.

Cllr Lukaniuk commented that concerns had been raised about rainwater running off the roof onto a heritage wall within a conservation area as there is no gutter in place. Cllr Brocklehurst stated that there didn't seem much difference between the amended and original plans. There was a general discussion and Cllr Lukaniuk summed up that we were unhappy about the application and the execution of it and there were further concerns the pergola had been erected over a drain. A vote then took place.
