## BRANDON TOWN COUNCIL

Minutes of the Full Brandon Town Council Meeting
Held on Monday 6 March 2017
In the Council Chamber, The Old School House, Market Hill, Brandon at 7.00pm.

The meeting commenced at 7.00 pm.

- APOLOGIES FOR ABSENCE and approval of reasons tendered. Cllr. P MacLoughlin.
- DECLARATIONS OF INTEREST and additions to Members Register of Interests. None declared.

#### 3. CLERK'S REPORT

Questions raised included the issue of the ongoing situation with the town clock and whether it would be possible to bring the electrics in house (police to advise date for the electrician to gain access to the secured area); tree planting and the requisite cages on the London Road (AC Trees to carry out the work); maintenance to the cemetery trees; the redundant mower has been sold at Methwold Auctions for £9 less auction costs making £7.02); three of the Nine Stiles to be refurbished and perhaps housed in the Heritage Centre (consent needed from the Trustees of the Heritage Centre),or one could be located in the front area of the council offices; replacement tree (No. 57) to be planted (BRPF to be contacted).

### 4. PUBLIC FORUM

Matters raised included the tidying up of a property in London Road (sofa bed, plasterboard removed); criticism of the District Council when the problem was reported; compliments to the contractors carrying out the maintenance to the cemetery trees; the cemetery compound not being fit for purpose and realistically, consideration should be given to purchase an industrial unit to securely store the equipment; the works mower being driven over a grave whilst being manoeuvred from the yard into the cemetery; the excellent work of the grounds staff improving the frontage of The Orchard with a new picket fence.

Agenda item 7 was now heard.

### 7. TO RECEIVE A REPORT FROM RAF LAKENHEATH

With little to report questions were invited. With regard to the MOD's series of objections to the planning application from Talervia Estates, the significant of the report (the Squadron Leader was unable to comment on the question); increased noise levels from the new generation of aircraft.

### TO RECEIVE REPORTS from County and District Councillors, Community Group Representatives.

A report received from Cllr. G Hughes (Town & Parish Forum) was noted. Suggestions for sharing with other Parish/Town Councils, included the work to the cemetery trees, improvement of the toddler's play area, the saving of the Brandon Day Care Centre. A concern was raised by Cllr. I Horner that only one written report had been received. Cllr. R Silvester verbally reported on the Fire & Rescue meeting held at Suffolk County Council. Sadly, a person has died as a consequence of a house fire in Brandon. A report from Cllr. P Etherington regarding the 2018 event will be included in the agenda pack. Cllr. P Ridgwell asked wnether SCC will be making available the results of the traffic survey presently being carried out at St Peters Approach/ St Peters Church. Traffic count figures from the four major roads in Brandon have yet to be made available. It was further reported that contrary to planning permission, the footpath at the rear of the old library has still not been re-instated.

#### 9. CORRESPONDENCE

Circulated at the meeting. In future, a spreadsheet will be provided listing correspondence received.

#### 10. URGENT BUSINESS

Road closure: Cars travelling into Brandon are ignoring the road closure signage causing several near misses. Caution is needed.

Stannah Lift Services: The main PCB control has failed and the following works are required to return the lift to safety. Option 1 supply and fit a new PCB; Option 2 remove main PCB, send away for testing, repair, overnight test and return and fit. For economic reasons, option 1 was chosen. Emergency Light LED unit: Required on health & safety reasons.
