A report was received from Cllr Lukaniuk in his role of County Councillor. Item one - Cllr Lukaniuk informed the meeting that Brandon station (located in Norfolk) has received listed status having been nominated by Suffolk County Council. This has now shed a different complexion on its preservation and use. Network Rail and the Railway Preservation Trust have funds which they will invest into the site. This may take some time before the project comes to fruition. Item two – Cllr Lukaniuk reported that the last football match at Brandon Remembrance playing fields had to be halted whilst the players and officials cleared an amount of dog mess which was on the pitch. No reports were received from District or Town Councillors.

A member of the public again reminded Council that confidential topics need to be added to the agenda minutes. A resident commented on the apparent lack of efforts to attract new Councillors. Cllr Lukaniuk replied that Councillors are working on co-opting new people to the Council. A resident commented that he had not seen any dogs using the playing fields as a toilet. Cllr Wittam confirmed he had seen it happening and it has been a problem for a long period, he also found several drug related items. Another resident asked what measures were in place to improve the training record of staff. Another member of the public was pleased regarding the news about Brandon station. He asked if there was any news regarding the signal box. Cllr Ridgwell commented that the signal box was going to be demolished. Cllr Lukaniuk commented that the signal box was actually in Suffolk and when he met with the Preservation Society regarding the station, he was told that it was a different matter and would be dealt with separately. He commented that the costs previously published to demolish the signal box were extensive. The resident arrived at Brandon market at 12pm on the previous Thursday and expressed a desire for a market in the afternoon rather than the morning, that currently takes place. Cllr Wittam remarked that this would be useful. The resident commented that dog mess is experienced in public places in Weeting too. A further resident expressed her thanks for the efforts with Brandon market on Thursdays. They commented that the notice board outside Old School House was in poor condition. The Clerk made note of this comment and commented that a new notice board was required at Old School House and the cemetery. Locality budget money was pledged by the District Councillors to improve the situation. Another member of the public wished it noted that the 21st August 2021 will be a one-day Brandon Festival. Details to be announced.
